Discussion – Questions

- James Thanks for MOED coming. Homeless population in Westport getting really bad. Looking for more resources for Homeless Services and outreach/behavioral health.
- Garrett safety component
 - Lots of safety issues in Federal Hill; carjackings, muggings, etc. Community leaders are working on a plan for greater coverage at FH business district with other resources without drawing resources from BPD.
 - o Mike- similar in South Baltimore.
- Sandy how much is the contribution for Warner St.
 - Chris- Initial commitment was for \$7.5M, additional funds will be between \$1M-\$2M depending on final accounting.
 - Casey Warner Street/Stockholm \$10M is a lot for that area, what is the plan for connectivity between that area and Pigtown/Carroll Camden?
 - Ethan- we can reach out to DOT about capital plans for Russell St and other potential projects connecting to the entertainment district.
- Sandy- Can we evaluate the goals, are there opportunities for reallocation?
 - Senator Ferguson- we need to move it to something a program, agency, project, grant;
 - Ethan there can be future opportunities for workshopping ideas beyond locking them into this budget.
- Senator Ferguson asked Mark Hooper from the Employment Connection Center if he had any comments or questions to the LDC regarding the ECC.
