Welcome & Introduction

Thank you for being here. Community members are joined by the following groups tonight:

- Pimlico Community Development Authority (PCDA): The appointed advisory body that recommends spending priorities to the Mayor's Office.
 Membership includes residents, community leaders, and elected officials.
- **Department of Planning:** The agency tasked with chairing the PCDA, staffing the PCDA, and managing the grant allocations. Also includes community planners for Western and Northwestern Districts.
- Mayor's Office: The Mayor's Office makes the final recommendation of how to allocate Pimlico Local Impact Aid and submits this recommendation to the City Council as part of the budget approval process.
- **Elected Leaders:** The eligible funding area includes City Council districts 5, 6, and 7, and State legislative districts 40 and 41. Some but not all leaders are part of the PCDA Board.
- City Agencies and Community Groups: Staff from partner agencies and community organizations are on the call to assist with answering questions about funding requests.

New or Revised Requests Since Previous Meeting

- **Dayspring Inc.** has requested an additional \$64,000. This request would fund a new portable classroom, allowing Dayspring to reach more young people with their early education services (total amount of their request is \$89,000).
- Robert Hunt Revitalization Center CDC has requested \$1M. This request would support the estimated renovation costs of a new community center in Park Circle, at the site of the former Good Shepherd Baptist Church.
